

CONTRACT OFFER

DEFINITIONS USED IN THIS CONTRACT OFFER

Terms and definitions used in this Agreement are used in the following values, unless the context specifically requires otherwise or specifically not otherwise specified:

Access code for Hotcallback.com is a code that allows you to receive communication services to entrepreneurs on the web.

User is a physical or legal entity which has acceded to this Agreement and got access to information services of Hotcallback.com portal.

Entrepreneur is communication service of IP-telephony Hotcallback.com.

Communication services (Services) is a providing a variety of information and online services, online information and services provided by Hotcallback.com, accessible on the Hotcallback.com domain.

CONTRACT OFFER SUBJECT

1. This Contract Offer determines the order of natural and legal persons (referred as "users") communication services (hereinafter referred to as "Services"), and establishes mutual rights and obligations of the parties involved in this Agreement.

2. Parties agree that the Services provided under this Agreement, in the form provided "AS IT IS", that means absence of any guarantees and commitments on the entrepreneurs in the case of failure to provide the Services or disruption of service (delays, failures, safety and reliability of delivery of correspondence, security of any user information, etc.).

ORDER TO SIGN THE CONTRACT OFFER

1. By signing the printed version of this form, or by clicking "I accept" in the personal office or registering on the site Hotcallback.com, or installing access code on the user's system Hotcallback.com site, or returning the message in any other way, you give your acceptance of the fact that your access to and using of this website is subject to the terms and conditions of this Contract Offer and any other terms and conditions contained on the website.

RIGHTS AND OBLIGATIONS OF THE PARTIES

1. The rights and obligations of the user:

1. The user has the right at any time to abandon the use of services by removing the access code to the system Hotcallback.com with custom web sites.

2. User agrees to abide by the terms of this Contract Offer.

3. User agrees not to take any actions aimed at undermining the security of the network or malfunction of software and hardware of this website.

4. The User agrees not to use the services for the dissemination of information, the content of which is contrary to the norms of national and international law.
 5. The user agrees to make payments in the amount and terms specified on the payment page of the site Hotcallback.com.
 6. The user confirms agreement with the prices published on the website Hotcallback.com including if they changed by Entrepreneur. Changes are effective upon posting on the site Hotcallback.com.
2. The rights and obligations of the entrepreneur:
1. The entrepreneur has the right to remove any content posted by users on Hotcallback.com without notice, if it considers that the nature or content of this information violates existing regulations of international law, is offensive, violate the rights and lawful interests of other citizens, or contrary to the Contract Offer.
 4. The entrepreneur has the right in violation of the user of this right to suspend or terminate the provision of the Services to this user without notice, including if it considers that the information presented to the user on the registration form is not true without refund of the amount paid.
 5. The entrepreneur has the right at any time to terminate the provision of services to users without prior notice and without refund of the amount paid for services rendered.
 6. The entrepreneur has the right to change the price of services by publishing new prices online Hotcallback.com.

LIMITATIONS OF LIABILITY

1. Entrepreneur completely exempt from liability for the inability to use the Services or the poor quality of service delivery.
2. Entrepreneur completely exempt from liability for complete or partial failure to perform its obligations or damage other websites Members under this Contract Offer if any failure to perform or injury is caused by force majeure, wearing man-made, namely: accident (malfunction) in electrical power or computer networks or other telecommunications systems used for operation Hotcallback.com or other websites without accurate user activity, as well as a result of intentional wrongful acts of third

4. The text of amendments and / or additions to this Contract Offer or a new edition of the Entrepreneur shall be notified to the public by publishing relevant information on the portal Hotcallback.com.

5. The provisions of this Contract Offer, as well as all subsequent editions, are binding on all Members Hotcallback.com, including previously registered.

FINAL CLAUSES

1. If any provision of this Contract Offer will lose its validity or will be found to be unlawful or will be excluded from this Contract Offer, it does not entail the invalidity of

the remaining provisions of this Contract Offer, which will remain valid and binding for execution by all parties.

2. All issues that not governed by this Content Offer shall be settled in accordance with the applicable regulations of international law and the local regulation documents of the Entrepreneur if they meet the applicable acts of international law.
